

DHST:

- ✓ Is a non-profit-making Supporters' Trust, open to all Hamlet fans
- ✓ Is independent of Dulwich Hamlet Football Club
- ✓ Is democratic - no matter how much a member contributes, they only get one vote. Nobody is paid. Board members are elected
- ✓ Believes the directors and owners of Dulwich Hamlet should act in the best interests of the community that the club serves
- ✓ Is a long term solution, not a quick fix for current problems

DHST Aims:

- ✓ To have a democratically elected representative on the Dulwich Hamlet FC board of directors. Although DHST is independent, it strives for this to give fans a voice in the boardroom
- ✓ To lobby, publicise, and campaign to encourage the board to take into account the interests of supporters when making its decisions
- ✓ To ensure that Dulwich Hamlet FC always has a football ground in the local vicinity and make sure that it is sustainable
- ✓ To acquire a stake in the football club via shares; this will make sure our voice is heard

DHST is:

- ✓ NOT trying to take over the club
- ✓ NOT trying to take over any other supporters' group

Supporters' Trusts:

- ✓ Have been set up at over 90 different clubs. 36 have a shareholding, 30 have Board representation, and at 6 clubs they either own or control the majority of the shareholding
- ✓ Have a real influence on the decision making process at a club
- ✓ Enable fans to work together as a democratic organisation
- ✓ Have strong links with the community that the club serves
